5. That he, at Calgary, in the Judicial District of Calgary, between the 1st day of December, A. D. 1959 and the 20th day of March, A. D. 1960, did commit an act of gross indecency with Michael Kelly, contrary to Section 149 of the Criminal Code. *Pleads Guilty*
6. That he, at Calgary, in the Judicial District of Calgary, between the 31st day of December, A. D. 1959 and the 20th day of March, A. D. 1960, did commit an act of gross indecency with Ernie Price, contrary to Section 149 of the Criminal Code. *Pleads Guilty*
7. That he, at Calgary, in the Judicial District of Calgary, between the 1st day of January, A. D. 1960 and the 20th day of March, A. D. 1960, did commit an act of gross indecency with Kenneth Morgan, contrary to Section 149 of the Criminal Code. *Pleads Guilty*
